ACCRINGTON TOWN CENTRE PARTNERSHIP BOARD TERMS OF REFERENCE

Aim

The key aim of the Accrington Town Centre Partnership Board will be to support and provide recommendations to Hyndburn Borough Council, which contribute to the implementation of the Levelling Up Fund Delivery Plan, the Long-Term Plan for Towns funding and the wider 10-15 year strategic Town Centre Improvement Plan.

The Board will also oversee the implementation of the Levelling Up Fund Delivery Plan, the Long-Term Plan for Towns funding and the wider Town Centre Improvement Plan

Structure and Operation

Chair / Deputy Chair

- 1. The Board will appoint a Chair and a Deputy Chair.
- 2. The Chair must not be a member or officer of either Hyndburn BC or Lancashire CC
- 3. The Chair and Deputy Chair will be appointed for a 3 year term, at the end of which they will be eligible for reappointment if they so wish
- 4. In the absence of the Chair and Deputy Chair, the Board may nominate an acting Chair from the other board members.

Composition of the Board

- 5. The Board will be composed of a range of stakeholders who have a relevant interest in Accrington town centre. The current membership of the Board is included with these Terms of Reference.
- 6. New members of the Board will be appointed by the Board. All members will be appointed for a 3 year term, at the end of which the will be eligible for reappointment if they so wish.
- 7. Whilst there are no limits set on the number of Board Members, it is envisaged that this will not exceed 15 Members.
- 8. The Board will include the following: the MP for Hyndburn, one member of Hyndburn BC, one member of Lancashire CC and a representative of Lancashire Constabulary

Conduct of Business

- 9. The Board will be quorate when five Members are present.
- 10. The Board will make its recommendations through a consensus of those present. Where this is not possible, decisions will be made by a simple majority on a show of hands, with the Chair holding the casting vote.
- 11. Voting will be done on the basis of one member, one vote.
- 12. An officer of Hyndburn BC may attend the meetings of the Board to advise (for example in respect of financial and legal matters)
- 13. The Board will keep minutes to record its decisions and recommendations.

- 14. The Chair will determine at his / her discretion whether any meeting of the Board will be open to the public, either in whole or in part, having regard to the nature of the business to be discussed.
- 15. The Chair will determine the items to be placed on the agenda at each meeting of the Board and will determine the frequency of meetings (subject to the minimum number of meetings being four per annum).

Remit

- 16. The Board will operate solely in an advisory and consultative capacity. For the avoidance of doubt the Board:
 - (i) has no power to make decisions on behalf of the Council but may make recommendations to the Council;
 - (ii) does not act as the agent of HBC nor is it a partnerships or joint venture of the Council:
 - (iii) is not intended to be a legal entity.
- 17. Members of the Board are required to be transparent in respect of their decisionmaking and will comply with the Board's code of conduct when conducting the business of the Board.
- 18. Where items under consideration are of a confidential nature, members will be required to treat theses accordingly.
- **19.** There is no intention for the Board to keep personal data, but the Chair will ensure that the requirements of the Data Protection Act 2018 are met in cases where this is required and must report any concerns of potential data protection breaches to HBC's Data Protection Officer

Review

- 20. Membership of the Board will be reviewed from time to time in order to respond to the development of programmes and projects.
- 21. Any requests to widen the focus of the Board's work will need to be proposed by the Chair and agreed by board members.
